If you're under 24 and your situation doesn't fit the rules for being independent on the FAFSA or WASFA, you have to give your parents' information. But if something unusual is going on, like if it's unsafe for you to get your parents' information or you're on your own without stable housing, you can ask for an exception called a dependency override.

However, the Financial Aid Office CANNOT approve a dependency override just because your parents won't share their information on the FAFSA or WASFA, you're not on their taxes anymore, or you're supporting yourself (unless you're at risk of being homeless).
